The rules for your taxes have changed

Here are some highlights of changes coming to the tax laws. Learn more at the January 17 meeting.: **PERSONAL**

Benefits - 83% of benefits from the changes go to the wealthiest Americans and corporations. ALL tax cuts for everyone else expire in 8 years. It is essential for you to plan for that time when your taxes will increase. Tax rates will see new brackets, with the wealthiest benefiting most.

Standard deduction – will almost double. *Personal exemptions end*, so families will eventually see tax increases.

Inflation — Inflation will now be linked to the Chained CPI rather than the Consumer Price Index, which will eventually *increase your taxes*.

Itemized Deductions — ALL state and local tax (SALT) deductions together are limited to \$10,000, which will hurt Oregonians and citizens in many other states. *Medical expenses* are dropped from a threshold of 10% to 7.5%, but this drop applies *only* to 2017 and 2018. After that, it reverts back to 10%. *Mortgage interest* drops to a limit of \$750,000 of debt. Only the military can deduct *moving expenses*. *Child tax credits* will double, which will help lower income.

Education – Because SALT deductions are limited, there will be less money for local schools. Education savings plans are now expanded to include K-12 *private for-profit school tuition*. Healthcare – The individual mandate dies in 2019, which experts predict will end health care for 13 million. Premiums are expected to rise.

CORPORATIONS AND WEALTHY

Tax rate – For top earners, the 1%, the tax rate drops from 39.6% to 37%, which is a major drop for the wealthy bracket. For corporations, the rate drops from 35 to 21%. These are permanent. Your tax cuts are not permanent.

Estate tax – Eliminated for the most wealthy Americans, who will benefit massively. In the

past, the first \$5.5 million was exempt from tax, now the first \$10 million will be exempt from tax (\$22 for married couples).

Alternative Minimum Tax – has been eliminated, which is a HUGE break for corporations. Most wealthy individuals will pay less. The bottom line is that this allows people to use more loopholes to avoid paying taxes.

SOCIAL SECURITY AND MEDICARE, MEDICAID CUTS PLANNED BY GOP

Cuts planned – Ryan and other Republicans have announced that the \$1.5 trillion debt created by the GOP tax bill must be addressed by cutting "entitlements," as they call them. Experts say up to \$25 billion for Medicaid may lost because of the GOP tax bill.

OTHER NOTES:

Planned cuts – to Meals on Wheels and the Heating Assistance to the elderly and disabled, and other, similar programs.

Comcast to increase charges now that net neutrality is ended by the Trump FCC. Look to see other companies follow suit.

Republicans planning to leave Congress have been increasing in number, the latest being Hatch.

Democrats who support unions, Social Security, Medicare and Medicaid *are preparing to run for office*

in LARGE numbers not seen in decades. Further, *Democrats are winning special elections*.

Legislative Report By Greg Monahan, Legislative Activities Vice President

The Legislature adjourned its short one-month session early in March. It was a busy one marked by several accomplishments in public policy, but no bills directly affecting Oregon state retirees.

An Oregon PERS Retirees, Inc. (OPRI)-sponsored bill to force PERS to refigure pensions immediately for retirees returning to the state, who must then pay Oregon state income tax and are therefore entitled to a slightly higher pension, failed due to harsh opposition from the outgoing PERS director.

As of now, PERS only makes adjustments in January, thereby costing returning retirees a fair amount of money the remainder of the year from not receiving the higher pension payments they would have received. OPRI is investigating the possibility of filing a lawsuit on behalf of retirees who have been shorted in this fashion and will introduce the bill again in the 2019 session.

Otherwise, there was very little action on PERS save for passing a bill aimed at reducing (slightly) the much-publicized deficit in the system.

In public policy, the Legislature did achieve several goals. It:

- tightened gun laws to prevent spouses convicted of abuse from buying guns,
- set up a Tuition Advisory Council to give students (and indirectly, their parents and grandparents!) a voice in whether and how much universities should be permitted to raise tuition, and
- repaired a loophole created by the (hostile) Federal Government so that Oregon Dreamers will continue to qualify for in-state tuition at the state's universities and community colleges.

Finally, the Democratic Majority blocked Republican efforts to give businesses a double-tax break in Oregon as a result of the new Federal Tax Overhaul Law, thereby insuring a small measure of equity in the state tax code and preventing an even bigger deficit in the next session.

That session, in 2019, promises to be a challenging one as Republicans look for ways to force retirees to pay more and seek to reduce the benefits of future retirees in the state workforce. As always, AFT and

Research Keeps Affirming It

According to a study of Americans' beliefs from 5 different years between the early 1980s and the mid-2000s, the most satisfied Americans were union members.

In fact, the data was so clear that union membership was seen as a predictor of a higher quality of life.

Researchers Flavin and Shufeldt found 4 factors leading to this positive feeling: greater satisfaction on the job, greater job security, more opportunities for "social interaction and integration," and satisfaction from participating in a "more engaged democratic citizenship." *This applies to retirees, as well.*

Even better, they discovered that states with higher union membership levels saw higher qualities of life and satisfaction among the states as a whole.

But Unions Have Enemies Today

Flavin and Schufeldt's study is just one of many over years with the same findings. But union membership has declined since the Reagan administration to only 11.3% of Americans today. The decline of the middle class is tied to the decline in union membership.

Why? Because unions have enemies. In states like Michigan and Wisconsin, the Kochs' network is working to fight public unions' rights to negotiate contracts

At the national level, Republicans in Congress have been working to make it harder to organize and even to join a union. They are working to weaken the Labor Relations Board and to establish a national right-towork (for less) law.

And now we find a case before the Supreme Court – *Janus vs AFSCME* – funded in part by the Kochs that challenges unions' right to charge fair share fees to non-members for the costs of negotiating and sustaining a contract.

Here's why unions worry them:

its allies will be actively involved in efforts to block such attempts as well as continuing to improve educational opportunities for Oregon's kids from pre-school to grad school.

All of you reading this column need to stay vigilant and involved, and don't ever forget to vote!

Today, most Americans don't know much about unions. Unions are simply the uniting of a group of workers in a workplace or similar workplaces who want to collaborate to improve wages, hours, and working conditions through a legal contract.

Unions also have a voice to protect these rights at state and national levels. They give legal standing to workers of any job or profession to meet with employers as equals, regardless of workers' level of wealth or social position.

Unions are traditionally *democratic* organizations serving many industries, including artists, actors, teachers, auto workers, writers in the digital media, firefighters and police.

Unions are good for all Americans

Quality of life: The average wages of union workers average 30% higher than those of non-union workers. 92% of union members have job-related health coverage vs 68% of non-union workers and are far more likely to have guaranteed pensions. And unions work to protect retirees from losing pensions.

Protections: Union contracts protect employees from unfair treatment or dismissal by the employer and protect health and safety on the job. Unions help ensure dignity on the job.

Higher quality work: Research finds that unions are linked to higher productivity, lower employee turnover, better workplace communication, and better-trained workers.

Training: Unions provide quality training in professional skills. In AFT, we see a wide variety of offerings for all members, even for retirees.

Economic: AFT members save money through discounts on a wide variety of services and products.

Our fight goes on! And we are winning!

West Virginia teachers went on strike this year and won. Oklahoma teachers are getting ready to fight. Union-supporters like Conor Lamb are winning elections.

Today, the majority of Americans are saying our democracy is under threat. More Americans support unions. And unions are fighting for *all* our rights, not just a few, as unions make all of society more just, democratic, and - yes - happy.



New Medicare cards; answers to Social Security-related questions

The following information is reprinted from the Benefits Watch newsletter of the National Committee to Preserve Social Security and Medicare. (www.ncpssm.org)

Next month, people with Medicare will begin to receive new Medicare cards in the mail.

The current Medicare card is susceptible to identity theft be-



cause it displays the Social Security Number (SSN), which is linked to many other banking and credit card accounts.

The National Committee has long advocated for this change, which will lead to a safer, more reliable Medicare experience.

Here's what you need to know:

- The new cards will be mailed in waves based on geographic location.
- The new cards will contain a unique number, different from your Social Security number.
- Medicare providers are ready to accept your new card when you need care.
- Destroy your old card and begin using your new card right away.

Remember Medicare will never contact you uninvited to ask for your personal information.

Starting in April 2018, people with Medicare will be able to check the status of card mailings in their area on Medicare.gov.

Did you know that a team of experts in the field of Social Security policy is available to answer your questions about benefits? For 35 years, the National Committee has been helping thousands of our members and supporters with a broad range of concerns on Social Security.

Whether you're currently retired or approaching retirement, the National Committee's "Ask Us" section can help answer your questions about Social Security. You can either search our archives for valuable advice on a broad range of concerns at www.ncpssm.org/AskUs or email your question to askus@ncpssm.org.

Here is a sample question: About a year ago I purchased a new car. The Credit Union (after a credit check) asked, "Did you know someone else is using your Social Security number?" I called the local Social Security office and was told, "You will have to pursue this on your own. There are no laws on taking on someone else's ID." Can you possibly give me some advice on where to pursue this?

Answer: Depending on the extent to which your identity has been compromised, you may need the help of the Social Security Administration and the Federal Trade Commission. The Social Security Administration has an online publication on Identity Theft and Your Social Security Number. Go to http://www.ssa.gov/pubs/10064.html#contacting for information and advice.

More broadly, the National Committee is concerned about older Americans' vulnerability to identity theft that stems from the use of the Social Security numbers (SSN) for purposes that are unrelated to the administration of the Social Security program. That's why we have long advocated for the removal of SSNs from Medicare cards. Thankfully, legislation calling for this change was enacted in 2015 and is now scheduled to be implemented starting in April.

AFT Convention; Election preparation By Louise Currin, President

I was honored to represent AFT-Oregon Retirees at the July 2018 AFT Convention in Pittsburgh. Much of the conversation centered on the recent Janus decision that essentially eliminated fairshare representation. This means that locals need to increase their organizing efforts, and AFT nationwide is experiencing an increase in membership. In that spirit AFT-Oregon Retirees will recommit to increasing its membership.

AFT-Oregon Retirees presented a resolution to the 2016 AFT-Oregon Convention that would support development of a retirement program for workers who are not covered by existing retirement plans. That resolution was adopted and forwarded to AFT, but even with clarification it was misunderstood and not passed on to the 2016 AFT Convention. A similar resolution did come forward this year and I had the opportunity to address the convention urging its passage. It was approved unanimously.

If it seems like political campaigns are getting started earlier and earlier, they are. That said, negative TV ads

don't usually stain our screens until the fall. This year is obviously an exception, probably because the race between Democrat Kate Brown and her Republican opponent Knute Buehler is already close.

I have to confess to a particular dislike for the ads from "Priority Oregon," a "dark money" group (meaning they won't tell us exactly who funds them) that most reports say is a conservative, antigovernment business-funded organization.

Why these ads in particular? Because they are truly, nastily deceptive. In particular, their ads feature a tearful widow effectively blaming the governor for the suicide of her husband by "blocking" construction of a counseling center (a VA/federal facility over which she has little or no say) and another emotional ad claiming ambiguously that she somehow has hurt foster kids, presumably a reference to the state shutting down some programs found to be unsafe.

What makes me particularly angry about these ads is that they appear to attack the governor from the Left, that is, they attack her for *not* providing state services, for *not* spending money. But if reports are correct, and this is a conservative, business-funded group, then they would oppose the state spending any money at all and would oppose it providing the very services they are falsely attacking the governor for somehow not providing!

I have no principled objection to conservative groups attacking a candidate for not being conservative. I don't agree with them, but at least they are the result of an honest disagreement. But these ads are evil. Not only are they false, but they take hypocrisy to a whole new level, so regardless of how you feel about the race, I'd urge you to reject these particularly deceptive ads.

In other political news, several ballot measures will be up for a vote in November. AFT-Oregon supports **Measure 102**, sent to voters with bipartisan support in the Legislature. It would lift a ban on government working with non-profits and local businesses to build affordable housing. Given Oregon's (and particularly, Portland's) terrible issues with homelessness, this is one small but important way to address that issue.

As usual, there are also some terrible ballot

Some Veterans or their beneficiaries can get new tax refund

The federal government is urging some 133,000 veterans who had money improperly withheld from their severance payments for combat-related injuries or other disability compensation to apply for tax refunds.

In some cases the improper withholding dates as far back as 1991. The Department of Defense (DOD) is sending letters to eligible veterans this month, stating the amount of the disability payment and telling them what to do to receive a refund. Survivors of veterans who would have been eligible for this refund may also apply. The DOD says veterans who do not get a letter may still be eligible for a refund.

The National Veterans Legal Services Program discovered the faulty withholding. Bart Stichman, the organization's executive director, said the government's action now "is long overdue. These are people who served in combat and were disabled in combat, and they deserve the full amount of what the military should pay them."

The Internal Revenue Service has set up two ways for veterans to be compensated for these taxes, which should not have been deducted when the veterans received their one-time lump-sum disability severance payments. - Measure 105 would repeal Oregon's sanctuary law that helps protect against racial profiling and keeps the state from being overrun by President Trump's ICE agents.
- Measure 103 is being falsely sold as a way to protect Oregonians from taxes on groceries, but there ARE NO taxes on groceries! It's a sneaky way for the big out-of-state companies—Albertson's, Kroger, Costco and others—to get out of paying any kind of business taxes at all.
- And then there's Measure 104 which would create hopeless gridlock in the Legislature by expanding the requirement for a three fifths majority from straight tax increases to requiring the same super majority to close tax loopholes or raise any fees at all. That would make it all but impossible to reign in runaway tax breaks.

AFT and other unions will be working hard to defeat these harmful measures!

The state has been closing some prisons as criminal justice policy seeks alternatives to incarceration. He added that the state should use the money saved from that change to fund universal pre-K education for Pennsylvania children. "Let's not incarcerate. Let's educate," he said.

In addition to joining the AFT Army (see AFT-Oregon President David Rives in picture below, right), AFT-Oregon members were active on the floor of the convention. AFT-Oregon Retirees President Louise Currin spoke in favor of retirement security (picture below, left). Oregon delegate Sami Al-AbdRabbuh spoke on the AFT-Oregon resolution in support of sanctuary schools and campuses. That resolution passed unanimously.

Delegates voted to invest in our future and fight austerity measures, launch a national campaign to highlight the debt crisis in America, support the rebuilding of Puerto Rico, and call for total repeal of the Trump administration's 'zero tolerance' immigration policies and indefinite family incarcerations.

Convention speakers included U.S. Senator Bernie Sanders and Randy Bryce. Delegates were urged to run for office and left the convention feeling inspired, hopeful, and ready to keep fighting.
